Call to Order I

The meeting was duly noticed and called to order at 5:30 p.m. by Mr. Dantzler, who chaired the meeting in Ms. Bidar-Sielaff's absence. Mr. Anderson confirmed that appropriate notices had been given and the meeting was being held in compliance with the open meetings law.

Routine Business Matters II

Approval of Meeting Minutes II A

There was a motion by Mr. Canty, seconded by Mr. White, to approve the meeting minutes of July 14, 2025, as submitted. Motion carried.

Board Chair's Report III A 1

Future Meeting & Event Schedule III A 1 a

Mr. Dantzler reminded trustees of upcoming meetings and events.

Student Liaison Report III A 2

Mr. Hashmi reported that he has learned that international students remained concerned about their ability to study in the United States, because of uncertainty related to federal policy. He is working on a project that would look a options for culturally diversifying offerings in Madison College cafeterias. He plans to survey students about their experiences with the college's internet hot spot lending program.

Student Senate Report III A 3

Mr. Villarreal reported that Dr. Berne will attend tomorrow's Student Senate meeting.

All student appointments to Shared Governance councils have been made. These councils allow student to participate in the development of policies that support student success. Student senators will table at WolfPack Welcome events.

College/Campus Announcements III A 4

Dr. Thomas informed the Board of recently approved international travel activities that will provide staff professional development and student exchange and recruitment opportunities. The presented international travel has been conditionally approved and final decisions will be made for each activity based on a review of health and safety conditions. On an annual basis,

Madison College reports to WTCS on the number of international students who were provided with waivers to pay in-district tuition rates. This year the college utilized the program for 11 international students. This year, the college anticipates more than 200 international students using student visas, with approximately 200 more attending the college without the institution's visa support.

Dr. Grady reported that her office recently hosted the Chicano Institute event with the goal of fostering belonging and empowerment for Xicane/Latine youth and families. Additional events over the course of the summer include Juneteenth celebrations, Pride Month observances, and BIPOC Mental Health Awareness.

Dr. Ramirez introduced the four Finance and Administration student interns. Each year the college shares a supplier diversity report that outlines the college's spending with diverse suppliers, with the goal of ensuring that the supplier base reflects a wide range of qualified businesses.

Dr. Casper introduced Mr. Wozniak who shared information about the college's involvement in SkillsUSA. SkillsUSA competitors and advisors were also introduced and shared their competition experiences. Students Services is holding a variety of events to assist students with preparations for the upcoming semester. The college is experiencing growth in both headcount and FTE for the current fiscal year. The college has not yet achieved pre-pandemic enrollment levels.

Dr. Berne shared that while higher education has made improvements to access, some of the intended and unintended barriers of access based on gender, race, ethnicity, language spoken in the home, geography, and socio-economic status. Commitment Two explicitly guides the college to examine the processes and practices that have created and maintained these barriers to access and student success. She introduced Dr. Thomas, Dr. VilaCruz, Dr. Carter, and Ms. Willis to share information related to initiatives that are aimed at assisting the college in meeting Commitment Two.

Dr. Ramirez reported that annually, all Wisconsin Technical College System (WTCS) districts are required to prepare and submit a Three-Year Facilities Plan to the Wisconsin Technical College System State Board. The plan must be approved by the District Board and submitted to the WTCS. She invited Mr. Brechlin to share some of the details of the plan with the Board.

There was a motion Ms. McNeary, seconded by Mr. White, to approve the Madison College Three-Year Facilities Plan, dated August 2025, for submission to the Wisconsin Technical College System. Motion carried.

Ms. Grigg reported that the attached resolution is the authorization to begin the borrowing process and totals \$5,000,000, including \$1,500,000 for building remodel and improvements, and \$3,500,000 for the cost of acquisition of movable equipment and technology. Once the borrowing is authorized, the resolution is published as public notice per Section 67.12(12)(e)5 of the Wisconsin Statutes. Bids are then received. The second resolution is the issuance of the notes is for the public purpose of the acquisition of movable equipment and technology costing \$5,000 or more per unit or set (\$3,500,000), and for the purpose of paying the cost of building remodeling and improvement projects (\$1,500,000). The resolution limits the delegation of authority by stating that the General Obligation Promissory Notes may not be issued unless the True Interest Cost is equal to or less than 5.00%.

TOPIC: Authorizing the Issuance of Not To Exceed \$5,000,000 General Obligation

Promissory Notes, Series 2025-26D

ISSUE: The approved FY2025-26 budget includes the capital projects budget and

authorized the borrowing of \$31,000,000. The initial process to borrow for capital projects includes securing bond counsel opinion and obtaining a bond rating.

The attached resolution is the authorization to begin this process and totals \$5,000,000, including \$1,500,000 for building remodel and improvements and \$3,500,000 for the cost of acquisition of movable equipment and technology. Once the borrowing is authorized, the resolution is published as public notice per Section 67.12(12)(e)5 of the Wisconsin Statutes. Bids are then received. An authorizing resolution will be forthcoming to the Board to set the parameters to award the sale of the bonds to the lowest bidder from the bidding process.

Additional borrowing(s) will be scheduled and brought to the District Board for authorization later in the fiscal year.

General Obligation Promissory Notes, Series 2025-26D

ISSUE: The Madison Area Technical College District Board previously approved

authorizing the sale of \$5,000,000 of General Obligation Promissory Notes. The issuance of the notes is for the public purpose of the acquisition of movable equipment and technology costing \$5,000 or more per unit or set (\$3,500,000), and for the purpose of paying the cost of building remodeling and improvement projects (\$1,500,000). These activities were included in the FY2025-26 capital

projects budget approved by the Board on June 4, 2025.

The resolution limits the delegation of authority by stating that the General Obligation Promissory Notes may not be issued unless the True Interest Cost is

equal to or less than 5.00%.

We will provide information on the winning bidder, purchase price and interest rates, at a future board meeting. Attached is the Authorizing and Parameters Resolution.

TOPIC: General Fund Financial Report as of July 31, 2025

ISSUE: Review current year to date revenues and expenditures in the general fund. The current fiscal year's general fund revenues are 10.97% of the current budget. This compares to 12.55% during the prior fiscal year.

- Local Sources (Tax Levy) recognizes 100% of our annual tax levy as revenue, even though a portion will be collected in the next fiscal year. Also included are the revenues from dissolved TIDs, taxes from DNR lands, and net refunds for personal property. Tax Levy revenues to date are 0% of budget, compared to 0% last year.
- State Sources includes general state aid, performance-based funding and property tax relief aid. Also included are inter-district tuition supplement, state incentive grants, exempt computer state aid, aid in lieu of property taxes, and the WI GI bill remission aid. The State Aid revenues received to date are 3.19% of budget, compared to 3.20% last year.
- Program and Material Fees revenues represent the fees for summer school, and the first and second semesters of the current school year. The program fee revenues to date are 40.72% of budget, compared to 48.59% last year. The material fee revenues are 45.52% of budget, compared to 46.41% last year. Decrease in program fees are primarily Collegiate Transfer and Associate Degree.
- Other Student Fees include graduation, nonresident tuition, Group Dynamics and community service classes. Revenues to date are 44.95% of the amount budgeted. Last year, revenues to date were 37.84%. Out-of-State tuition for Collegiate Transfer and Postsecondary/Vocational Adult/Non-Postsecondary are performing better vs budget along with Other Student Fees.
- Institutional Sources include interest income, lease/rental income and royalty income, along with miscellaneous revenues. The revenues to date are 28.28% of the budget. Last year's revenues were 24.87% of the budget.
- Federal Sources consist of cost reimbursements on federal grants and administration for student financial assistance. Current year revenues are 0% of the budget, compared to -9.11% last year. Expected that revenue will be generated throughout the year.

The functional expenditure classifications are defined by NACUBO's Financial Accounting and Reporting Manual for Higher Education. The current fiscal year expenditures are 8.35% of budget as compares to 7.57% for the prior fiscal year.

- Instructional includes expenditures for all activities that are part of the College's instructional programs. Current year Instruction expenditures are 3.92% of budget, compared to 3.60% last year.
- Instructional Resources includes all expenditures incurred to provide support for instruction, such as library and academic administration and support. This year's Instructional Resources expenditures are 9.40% of the budget, versus 6.88% last year.
- Student Services includes expenditures incurred for admissions, registrar, and other activities that contribute to students' emotional and physical well-being, such as counseling, student aid administration, and intercollegiate athletics. Student Services expenditures are 5.33% of the current year's budget, compared to 6.41% last year.
- General Institutional includes expenditures for centralized activities that manage planning for the entire institution, such as the President's Office, human resources, and financial operations. General Institutional expenditures equal 18.48% of budget, compared to 18.92% last year.
- Physical Plant includes expenditures for the administration, supervision, maintenance, and protection of the institution's physical plant. This includes items such as janitorial services, care of grounds, maintenance and operation of buildings and security. Physical Plant expenditures equal 37.15% of budget, compared to 28.35% last year. Increase due to higher encumbrances compared to prior year.
- Public Service includes expenditures for activities established for non-instructional services, such as the athletic director's office. The current year's expenditures are 6.82% of budget, compared to 7.04% last year.
